

Discussion was opened. Ann Grigorian had a question about if this is only for people outside of York. Gary advised it is for people outside of York. Lynda Fairman asked if it is intended for only people outside of York because the amendment did not state that. George Clark stated it should be open to people in York as well. George stated to leave as written. Greg Woznick asked what happens if someone joins who is not wanted. Danny Diggs advised it needs to add the word organization or business to open it up to people and businesses. George withdrew his motion. Lynda Fairman advised the bylaws cannot be amended after presented. We can vote as presented and then amend later. Danny Diggs clarified on Greg's question that the committee still has to vote to allow someone to join.

Vote by hand count as written: 24 in favor, 14 opposed Failed due to requirement of 2/3 needed to accept

The proposed change for the proxy is that you have to be a member to be a proxy to stop non-members from voting. The proxy must be a committee member, the proxy will be for attendance only, can use a proxy twice during the two year term. The proxy must also be from the member's voting district.


Discussion was opened. Ann Gregorian wanted to clarify if the amendment is to remove a voting proxy altogether, Gary advised yes. Ann agrees with that however she is against proxies and thinks there may be a better solution and she will be voting against. Dave Staskelunas asked why we have proxies at all. Samantha Abbott felt we need proxies because events in life occur and prevent attendance. Lynda Fairman advised the party plan allows for proxies and since we are a unit of the party, we follow the party plan. Lynda did acknowledge that there is another side where some members only come in to vote when called upon. George Clark suggested asking RPV legal staff for an opinion on proxies.

Vote by hand count as written: 3 in favor, 39 opposed Failed due to requirement of 2/3 needed to accept

The reapplication amendment would require a member to reapply and be voted back in once three consecutive meetings are missed. You would be treated like a new member.

Discussion was opened. George Clark advised that if we proceed this could penalize people and he would vote against it. Stephen Roane asked if non-regular events count toward meeting attendance and was advised no. Jon Grigorian advised that he agrees with George. He also asked about the three meetings; it is tied to the party plan. The party plan requires a quarterly meeting and we have monthly meetings and could the three meetings be changed to four.

The bylaws committee requested additional information and ideas be sent to the committee.

#### **Guest Speaker:**

Orlando Martinez the RPV- Director of Candidate Services has been in the position for two years. He has been to 71 committee meetings so far. The Commonwealth is in danger if the party loses in November. He is grateful to attend. He advised Mark Peake sends his best. In 2021, Southwest Virginia came out to vote and to win, it will take everyone coming out to vote again. The data shows Republicans are slipping and there are several places where Republicans are losing ground. It will take all voters coming out again in this off-year race. These voters came out in 2024 but not 2021 or 2023. Although the party has a moderate stance, Republicans are being painted as radical. Law enforcement lost the ability to pull over vehicles for the smell of marijuana and other violations. This was due to Republicans being in the minority. To make a difference in November it will take a lot of work. RPV will provide resources and candidates will need to raise money and run campaigns. Polls are not looking good right now. Several items such as abortion, 2<sup>nd</sup> amendment issues, law enforcement, and other basic things are at risk. RPV has a website to help campaigns, the GOP data center. It helps to find voters and determine which people to contact. We need to canvass by knocking doors. This is the best method to contact voters. The chair can access data and authorize access to the data. The data will help the committee contact voters who really need to vote this year. Data can be collected from going door to door and entered back into the system for future elections. Orlando can be reached at 832-670-9303 or orlando@virginia.gop. He advised the data is also open to the women's groups as well. Every Wednesday he does data training on a zoom with a new link weekly. Orlando advised he is a resource for the party. He is happy to help. There is an upcoming event. Kitty will provide details and he asked we be sure to register.


#### **Visitors:**

The next Republican Women's meeting is coming up on June 9 and Tammy Gweedo will be speaking.


