#### **Approval of the August Meeting Minutes:**



on a retired state trooper. This was false. AC called the police because the retired trooper broke AC's door handle trying to enter his vehicle during a road rage incident and the judge threw out the case. AC did not "brandish" a firearm, it was in the vehicle like always and was visible. The false ad used old footage showing AC with an AR-15. The video was from something done in college. The second lie was that AC groped a girl. There was an issue at AC's house and AC called the police because the girl, who was and is AC's friend, took cash from him and tried to leave. All AC wanted was his cash back and he did not press charges. The third lie was that AC was a "sexual predator". This third lie was based on an old dating website where AC had created an account as a 16-year-old. AC has created a group chat that never had any members, but the ad stated it was a "sexting ring". AC has is having a cease and desist issued, he is going to file a lawsuit against his opponent because the ad has an omission that is not allowed. Unfortunately, ads that just lie about an elected official are not illegal. AC has been given \$200,000 to run counter-ads and is working to spread the word. He had an interview with Wavy Truth Tracker where Andy Fox allowed AC to explain the lies in the ad. The Dems have upped the ad funding for the opponent to \$500,000 now. AC needs everyone to speak to people they know and provide the correct information. He is using digital media, door knocking, poll workers, and ads to combat lies. He suspects that once the cease and desist is issued, the Dems will create new ads. AC needs help with door knocking, funds to pay expenses, and people to work the polls.



Article VI, Section B was changed to rename the "Audit" committee to the "Financial Review" committee to better reflect what occurs. Article VII, Section C was struck to remove proxies. 
#### Visitors:

Douglas Holroyd advised they are working on the recycling situation. Doug advised Steve found the issues earlier the year with TFC commending him for finding the issue.


